American Canyon High School desires to select a coach who is committed to developing young athletes both on and off the field. Applicants will be required to obtain **First Aid/CPR, NFHS Fundamentals of Coaching, NFHS Sudden Cardiac Arrest, NFHS Concussion in Sports and NFHS Heat and Illness prevention, as well as all other Napa Valley Unified School District Human Resources required documents.** The season begins in November and runs through February however some off-season activities are expected. The coach receives a booster Stipend **at the end of the season.**

Must be willing and able to work with our ACHS staff, student athletes, parent's administration, and American Canyon High Athletic Booster Club. Must have basic knowledge of the following:

- 1) Character-building aspects of sports, including techniques and methods of teaching and reinforcing the core values comprising sportsmanship and good character;
- 2) Knowledge of physical capacities and limitations of the age group coached;
