Candidates should be experienced in the sport, have coaching experience and a resume of working with student-athletes at the high school level. Napa High School desires to select a coach who is committed to developing young athletes both on and off the field. **Applicants will be required to obtain First Aid/CPR, NFHS Fundamentals of Coaching, NFHS Sudden Cardiac Arrest, NFHS Concussion in Sports and NFHS Heat and Illness prevention. As well as all other Napa Valley Unified School District Human Resources required documents.** The season begins in August and runs through November, however some off-season activities are expected. The Assistant Coach receives a Booster Stipend **at the end of the season.**

Must be willing and able to work with our NHS staff, student athletes, parent's administration, and Napa High Athletic Booster Club. Must have basic knowledge of the following:
